# THE 14 WORKING POINTS CHART

Belgrade and Pristina's initial reactions to Troika's "14 working points"

### TROIKA (official)

1. Belgrade and Pristina will focus on developing special relationships which will be based on their historical, cultural and human dimensions.

### BELGRADE (official)

1. The focus of the talks is on determining the future status of Kosovo and Metohia on the basis of principles defined by the United Nations Security Council Resolution 1244, which „reaffirms the respect of all member countries for the sovereignty and territorial integrity of the Federal Republic of Yugoslavia (today, the Republic of Serbia) and other states in the region, as mentioned in the Helsinki Final Act and the Annex 2", and „reaffirms its request from previous Resolutions for a wide autonomy and substantial self-governance for Kosovo". Any change of the focus of the talks requests a change of the valid and binding Resolution 1244.

### PRISTINA (interpreted)

1. Belgrade and Pristina will focus on developing special relationships **between two independent states, Serbia and Kosovo.**

2. Belgrade and Pristina will in the future resolve problems in a peaceful manner and will not enter any actions or intentions which could be characterized as a threat to the other side.

2. All three sides, representing the institutions of Serbia, the provisional institutions of self-government in the province and the mediators of the international community, are required to restrain from any unilateral acts.

3. "Disagrees on this point" with the Serbian delegation.

3. Kosovo will be fully integrated into the regional structures, in particular those linked to economic cooperation.

3. The province of Kosovo and Metohia will be fully integrated into regional structures, in particular those dealing with economic cooperation.

3. Kosovo will be fully integrated into regional structures **as an independent state.**

4. There will be no return to the pre-1999 situation.

4. There will be no return to the pre-1999 situation, **but instead the future organization of the province should be determined on the basis of UN Security Council Resolution 1244**

4. There will be no return to the pre-1999 situation, **Kosovo will rule itself with full sovereignty.**

### BELGRADE (official)

10. In these, and possibly other fields of cooperation, Belgrade and the province of Kosovo and Metohia will create joint bodies in order to implement affairs of common interest.

11. Except to the measure of its international obligations as a subject of international law, Belgrade will not interfere in the relations between Pristina and the international financial institutions.

12. The province of Kosovo and Metohia will have full competence over its finances (taxes, public revenues, etc).

13. The process of Stabilization and Association of the province of Kosovo and Metohia (Tracking Mechanism) will continue in cooperation with Belgrade.

14. The international community will, after determining the status, continue its civilian and military presence in Kosovo under the UN mandate and in accordance with a Security Council decision.

11. Belgrade will not interfere in the relations of Pristina with international financial institutions.

12. Pristina will take care of its finances fully independently (taxes, budget revenues, etc).

13. Kosovo will continue the process of stabilization and association with the EU without any interference from Belgrade.

14. The international community will keep its civilian and military presence in Kosovo even after the status is determined, but this international presence will be temporary and last until the international community accepts the practical reality of full independence.
